## TANZANIA PADEL FEDERATION (TPF)

### **TERMS AND CONDITIONS FOR REGISTRATION**

*(Applicable to Players, Clubs, and Coaches)*

---

#### 1. INTRODUCTION

These Terms and Conditions (“Terms”) govern the registration and participation of individuals and entities with the **Tanzania Padel Federation (TPF)**, a sports governing body operating in accordance with the laws of the United Republic of Tanzania.

By registering as a **Player, Club, or Coach**, you agree to be legally bound by these Terms.

---

#### 2. LEGAL BASIS

These Terms are governed by and interpreted in accordance with:

- The **Laws of Tanzania**
- The **Law of Contract Act (Cap. 345 R.E. 2019)**
- The **National Sports Council Act (Cap. 32)**
- Any applicable data protection and consumer protection regulations

---

#### 3. ELIGIBILITY

##### **3.1 Players**

- Must provide accurate personal details
- Minors must have parental/guardian consent

##### **3.2 Coaches**

- Must demonstrate relevant qualifications and/or experience
- Must comply with TPF coaching standards and ethics

### 3.3 Clubs

- Must be legally registered entities in Tanzania or recognized sports associations
  - Must provide valid operational and contact details
- 

#### 4. REGISTRATION & MEMBERSHIP

- Registration is subject to approval by TPF
  - Membership is **non-transferable**
  - TPF reserves the right to accept, reject, suspend, or revoke membership at its discretion
- 

#### 5. FEES AND PAYMENTS

- Applicable registration or membership fees must be paid as prescribed
  - Fees are **non-refundable**, unless otherwise determined by TPF
  - Failure to pay may result in suspension or termination of membership
- 

#### 6. CODE OF CONDUCT

All registered members must:

- Act with integrity, fairness, and sportsmanship
- Comply with TPF rules, regulations, and competition guidelines
- Respect other players, officials, and stakeholders
- Avoid any form of discrimination, harassment, or abuse

TPF reserves the right to take disciplinary action for violations.

---

#### 7. DISCIPLINARY ACTIONS

TPF may impose sanctions including:

- Warnings
- Suspension
- Expulsion
- Fines (where applicable)

All disciplinary processes shall follow principles of **natural justice** under Tanzanian law.

---

## 8. HEALTH & SAFETY

- Participants acknowledge that padel is a physical sport with inherent risks
  - Members participate at their own risk
  - TPF shall not be liable for injuries, loss, or damages except where required by law
  - Clubs and coaches must ensure safe playing environments
- 

## 9. INSURANCE

- Members are encouraged to obtain personal accident and medical insurance
  - TPF does not guarantee insurance coverage unless explicitly stated
- 

## 10. DATA PROTECTION & PRIVACY

- Personal data will be collected and processed for registration, administration, and communication purposes
  - TPF shall handle data in compliance with applicable Tanzanian data protection principles
  - Members consent to:
    - Storage of their data
    - Use of images and media for promotional purposes unless expressly declined
- 

## 11. INTELLECTUAL PROPERTY

- All TPF logos, branding, and materials remain the property of TPF
  - Unauthorized use is prohibited
- 

## 12. EVENTS & COMPETITIONS

- Participation in TPF events is subject to specific rules and eligibility criteria
  - TPF may modify schedules, formats, or rules as necessary
- 

## 13. TERMINATION

TPF may terminate membership if:

- Terms are breached
- False information is provided
- Conduct damages the reputation of TPF

Members may also terminate their registration voluntarily, but fees remain non-refundable.

---

## 14. LIMITATION OF LIABILITY

To the extent permitted by law:

- TPF shall not be liable for indirect, incidental, or consequential damages
- Liability is limited except in cases of gross negligence or legal obligation

---

## 15. DISPUTE RESOLUTION

- Any disputes shall first be resolved amicably
- Failing resolution, disputes shall be referred to:
  - The relevant sports authority, or
  - Courts of competent jurisdiction in Tanzania

---

## 16. AMENDMENTS

TPF reserves the right to update these Terms at any time. Updated versions will be communicated and/or published.

---

## 17. ACCEPTANCE

By completing registration, you confirm that:

- You have read and understood these Terms
- You agree to comply fully
- You consent to be bound by them
